In accordance with Section 2279 of the California Food and Agriculture Code, I hereby submit the Sonoma County Annual Crop and Livestock Report for 1986. These figures represent value of production regardless of utilization.

This report shows a total return of agricultural crops in the amount of \$212,907,220.

With a slight increase in the gross value of Sonoma County agriculture in 1986, this indicates the continued strength of the agricultural industry even with the continued pressure of urbanization.

 $\underline{\text{Milk}}$  values increased \$630,144. Milk continues to be the highest crop in value  $\overline{\ln \, S}\text{onoma}$  County.

 $\frac{\text{Wine}}{\text{crop}}$  increased in value \$4,864,610 in 1986. This is the largest grape crop ever produced in Sonoma County. There was also a slight increase in the grape price per ton.

Nursery Product values were up \$730,350. This increase is due to a rise in cut cut flower production along with a number of new nurseries, which helped increase production figures.

Apiary Products increased slightly due to increased honey production.

Apple Production was down in 1986. Total value was down over \$1,000,000 from the 1985 crop. The cause of this decrease was due to poor production. If it were not for the increase in fresh apple pack out and a slightly higher price per ton, the total value would have decreased even more so.

<u>Prune Production</u> values increased which was due to better crop reporting information.

<u>Livestock</u> and <u>Poultry</u> values were down due to the reduction of the number of chickens being processed and the number of chicks hatched.

Livestock and Poultry Product values were down \$783,100 from the 1985 Crop Report. This was due to a decrease in hatching egg production. Shell egg production was down slightly, however this was off set by a slight increase in egg prices.

I wish to express my thanks for the cooperation of all individuals, growers, and agencies who contributed information for this report. Recognition goes to the entire department staff. Direction for compilation of this report was given by Deputy Agricultural Commissioner II, John G. Westoby, with assistance by Marilyn J. Vernon, Agricultural Inspector III.
