5. Councilmember comment on matters not listed on the agenda

Cynthia Strecker reported that Rio Fest was a big success with over 1,200 attendees. Lisa Nahmanson reported that Bike Friendly Forestville is meeting the 3rd Wednesday of each month and they would like to come share with the MAC about their work.

6. Public Comments

Vesta Copestakes shared that she, along with the Russian Riverkeeper Clean Team cleaned up a great deal of trash left over the holiday weekend. She also mentioned that the mowing and ditch cleaning has been going great, but to be aware that it's important to get the trash cleaned up before the mowing occurs so that plastics don't get chopped up in the process.

Lonnie Lazar, Forestville Representative, joining through Zoom, reported that he got stuck in traffic returning from San Francisco and won't be able to attend the meeting in person, but will attend virtually as a member of the public.

7. County Update from Supervisor Lynda Hopkins / Staff

Supervisor Hopkins, joining the meeting via Zoom, apologized for not attending in person. She planned to bring her 5-year-old, who developed a fever of 101 degrees, so she decided to stay home and participate remotely. She thanked everyone for their flexibility.

Supervisor Hopkins provided an update on the Local Coastal Plan. Despite this being the Lower Russian River Municipal Advisory Council, there are river areas within the local coastal zone. On Thursday, the 18th, at Sea Ranch and via Zoom, there will be a formal update on the Local Coastal Plan from the project lead, Cecily Condon. She met with Permit Sonoma Director Tennis Wick and Scott Orr, his right-hand man for planning. A Coastal Commission meeting in Sonoma County is anticipated in November to consider the Local Coastal Plan.

Feedback has been received about the proposed change on next week's Board of Supervisors agenda regarding the Park Rangers' status change from peace officers to public officers. Illegal flyers in local parks contain misinformation about this change. The proposal aims to change their status to public officers, better reflecting their roles in education, information, safety, and issuing administrative citations and arrests for misdemeanors. Their powers will remain unchanged. This change is intended to facilitate a collaborative partnership with the Sheriff's Office, including hiring four new sheriff's deputies and a sergeant to enhance law enforcement in regional parks. Currently, there is no local peace officer training for Park Rangers, leading to a 45% vacancy rate. The new training for public officers includes over 300 hours covering emergency medical response, strategic communications, de-escalation tactics, safety, and public safety coordination. Public officers will assist with evacuations, enter disaster areas, and issue citations and arrests. Peace officers would call deputies if situations escalated, as they did not carry guns or were part of the 911 dispatch system. The locally available public officer training should help reduce the 45% vacancy rate.

A dispute between IOLERO's and the Sheriff's attorneys over Measure P will go to a judge for determination. Supervisor Hopkins, not being an attorney, offered to answer any questions to the best of her ability.

The Board of Supervisors decided, by a 4-1 vote, to modify the language for the Measure J ballot question to ensure accuracy. Language about water quality and animal welfare was removed as the measure does not explicitly regulate these areas. This decision was made to comply with the code requiring ballot questions to be factual.

Cynthia Strecker inquired about the status of the bridge over Dutch Bill Creek. Staff is

investigating the status of the repairs to this critical piece of infrastructure.

Supervisor Hopkins met with Sebastopol city council members, the city manager, and new consultants about an Enhanced Infrastructure Financing District (EIFD). This partnership with Sebastopol will explore different boundaries, potentially including the lower Russian River. This financing method would allow reinvestment into local communities. They are in the preliminary stages, and major project suggestions are welcome via email or during Q&A.

Regarding seasonal bridges, such as the one at Vacation Beach, there is ongoing investigation into making them permanent. This process will take time for financing and permitting. Keeping these bridges up longer supports evacuation during fire season, but managing them can be challenging due to environmental regulations.

During public comment, Vikki Miller inquired about the removal of water quality and animal welfare language from the Measure J ballot question. She asked who oversees animal welfare on larger farms that might be impacted. Supervisor Hopkins explained that the measure focuses on the size of farms and closing certain farms, not on water quality or animal welfare. The ballot question needed to be an accurate summary without speculative or misleading language, so the original language implying benefits not specifically addressed by the measure was removed to ensure clarity and compliance with election code. She further clarified that animal services investigate alleged animal abuse cases, and actions can be escalated to the district attorney if needed. California has stringent regulations from a statewide ballot initiative mandating minimum enclosure size for livestock.

Field Representative Debbie Ramirez shared a staff update regarding applicant recruitment for MAC terms beginning in January 2025. A draft of the flyer was shared and she noted that the application period would run through August 31 and that the community selection process would run through September, wrapping up in mid-October.

Also, Debbie will be sending a survey out to all MAC reps and alternates to get feedback about increasing attendance at future emergency preparedness events.

8. Discussion regarding Pavement Preservation Program timeline and process

Janet Thompson, Deputy Director at Sonoma County Public Infrastructure, began by expressing gratitude for the air-conditioned room provided for the meeting. She provided an overview of the county's paving program, emphasizing the substantial support from the Board of Supervisors, which allocates a significant portion of the general fund to the program. She clarified that the gas tax contributes less than 10% of the funding, with the majority coming from the general fund (50%), state Proposition Senate Bill 1 (SB1) (25%), and various other sources.

Thompson detailed that the county maintains 1,368 miles of road, 41% of which are in District 5. A two-year paving program is in place, with roads selected based on multiple factors and approved by the Board of Supervisors. Roads are evaluated biennially using the Pavement Condition Index (PCI), and data is managed with Street Saver software. The long-term road plan, approved in 2014, prioritizes roads based on traffic volume, community services, bike lanes, tourism, and functional classification.

During the Q&A session, several issues and concerns were addressed:

Council Member Mike Nicholls asked about the inclusion of evacuation routes in road prioritization. Thompson acknowledged that while evacuation routes are considered, they are challenging to define due to unpredictable disaster locations. Higher-volume roads are generally

prioritized, with community needs taken into account by the Board of Supervisors.

Council Member Mike Nicholls asked about bridge deck repairs, specifically a missed bridge in Cazadero. Thompson assured that they would look into patching the deep potholes with resin concrete as a permanent solution.

Council Member Vicki Clewes asked about traffic volume quantification, particularly on River Drive near County Park. Thompson explained that traffic to parks and beaches falls under tourism priorities, receiving extra attention.

Council Member Lisa Nahmanson asked how to get roads that don't score high on the paving list. Thompson recommended using SoCo Connect for maintenance issues and emailing the Supervisor's office for paving requests.

Council Member Lisa Nahmanson inquired about the interplay with Caltrans. Thompson clarified that the county does not have jurisdiction over Caltrans roads and directed to contact Caltrans directly for maintenance issues.

Council Member Betsy Van Dyke reported a clogged culvert on Neeley Road. Thompson advised emailing her or the Supervisor's office for further assistance.

Council Member Betsy Van Dyke mentioned plastic markers left by the Argonaut crew. Thompson instructed to contact her office to ensure the contractor cleans up.

Council Member Cynthia Strecker asked about checking if their road is on the paving list. Thompson stated that the list is approved biennially, with the next approval in Spring 2025. Updates can be obtained from the Supervisor's office.

A Public Commenter appreciated the recent reconstruction on Neeley Road but raised concerns about side roads used for equipment storage. Thompson recommended reporting issues through SoCo Connect and the Supervisor's office.

Public Commenter Marsee from Rio Nido noted frequent flooding and incorrect information on the Street Saver map. Thompson advised emailing her office to re-evaluate those roads.

A Public Commenter expressed safety concerns about the road between Mirabel and Steelhead Beach due to high traffic and vegetation overgrowth. Thompson acknowledged the issue and promised to look into clearing vegetation and addressing parking concerns for safety.

Thompson concluded by inviting further comments and questions via email.

Dear Supervisor Hopkins,

The Lower Russian River Municipal Advisory Council (LRRMAC) had a productive and eventful year, actively engaging the community and addressing numerous issues. This annual report summarizes the council's key activities, discussions, and decisions over the past year. Throughout the year, LRRMAC remained dedicated to addressing the concerns of the Lower Russian River community. Through regular monthly meetings, community engagement, and collaboration with local and state officials, the council worked diligently to improve the quality of life for residents.

February 16, 2023: Roads Update

- Officer elections were conducted, with Pip Marquez de la Plata elected as Chair and Lisa Nahmanson as Vice Chair.
- Discussions included updates on road repairs and paving in the Lower Russian River area, the Moscow Rd. project, and the Forestville Front Street sidewalk project.
- The Community Clean Up Ad Hoc committee provided updates on connecting with more groups for clean-up events.
- Introductions and Oath of Office for new council representatives and alternates.

March 22, 2023: Vacation Rentals & Rural Broadband

- Public comments emphasized the importance of public involvement and the need for hybrid meeting technology.
- Supervisor Lynda Hopkins discussed the housing element, road funding issues, and updates on emergency financial assistance following January storms.
- Updates on the vacation rental ordinance and rural broadband were provided.
- The Communications Ad Hoc committee outlined goals for facilitating access to MAC meetings and increasing awareness in the community.

April 13, 2023: Resource Guide for Municipal Issues: Who to call

- Formation of an Ad Hoc Committee to develop a River MAC Land Acknowledgment.
- The Communications Ad Hoc committee proposed three initiatives, including designating Summer 2023 as LRRMAC Awareness Summer and committing to participation at local farmers markets.
- Updates on the governance study

May 11, 2023: IOLERO & Fire Season Readiness

- Public comments addressed issues related to the Russian River Sanitation District rate increase, homeless encampments, and code enforcement.
- Supervisor Hopkins provided updates on the Local Coastal Plan, housing element, wastewater regulations, and various county initiatives.

June 9, 2023: SocoConnect

- Public comments highlighted concerns about local infrastructure and public safety.
- Discussions on the summer outreach initiatives and participation in local events to increase community engagement.

July 13, 2023: Decommissioning of Potter Valley Dam

- The council discussed amendments to the bylaws and the importance of effective communication with the community.
- The Communications Ad Hoc committee outlined plans for outreach at local farmers markets and other community events.


Cross to Westbound Lane of River Road from Mirabel Park and Ride here. "How about a crosswalk"? says Vesta

Here's where it gets even more dicey!! Mile marker 17.48 Narrow and Dangerous!




At the mile 17.33 no parking sign:

There is a section with a ton of Poison Oak where beach-goers might move back into the road to avoid it. By the way: who maintains that pretty sign?






One individual for scale and this is wednesday at 10:30 so no crowds!! Imagine if this were a weekend!!




If this were cleared there would be more walking space:
