Land Acknowledgement:

All of us here tonight and everyone in the surrounding Sonoma Valley are on the ancestral lands of the Pomo Coast Miwok Patwin and Wapo tribes. Dear Senator McGuire (Dodd),

On behalf of the North Sonoma Valley Municipal Advisory Council (NSV MAC) and the Sonoma Valley communities that it represents, I respectfully request that your office convene a Town Hall community meeting as soon as possible to discuss the Sonoma Development Center (SDC) development process.

The state of California's Department of General Services has issued a Request for Proposal (RFP) with responses due by July 15, however no SDC Specific Plan has been adopted by Sonoma County, nor has the draft Environmental Impact Report been published. With the state's RFP process moving ahead, the community is uncertain and concerned about process expectations and transparency, specifically:

The 750+ acres of SDC open space are not included in the campus footprint acreage (180 acres) specified under the RFP. The SDC open space is adjacent to the Sonoma Valley Regional Park on the east and to Jack London State Historic Park on the west. Its transfer to these respective entities is promised in the statute authorizing the specific planning process now underway, but no timing or plan for transfer has been confirmed or announced.

We would like to discuss how we might work with our state representatives to facilitate an immediate transfer of the SDC open space acreage to the adjacent parks, keeping it fully accessible to the public. This transfer would be a tangible process outcome and address a top community priority. It would build considerable goodwill as we proceed with this process.

The interaction between the state's RFP and Sonoma County's Specific Plan is unclear. One example: the NSV MAC and broader Sonoma Valley communities have been consistent in their support of affordable housing at the SDC, however the range cited in the RFP of up to 1,000 residential units remains considerably higher than the 450 to 800 units recommended by local stakeholders and Supervisor Susan Gorin to county planners for appropriate housing density at this site. We do not know yet the number of housing units the Specific Plan will recommend.

We would like to discuss how the state's anticipated entry into a purchase agreement with a developer will interface with the county's unfinished specific planning process as the disposition moves ahead, and how the community can help ensure its recommendations are part of the final disposition and redevelopment of the campus.

There has been extensive and consistent community input on the SDC site planning process over the last 5+ years, including recent letters reflecting community input from the NSV MAC, the Springs MAC and the Sonoma City Council. We are at an important juncture in this process and feel it's the right time to take this conversation to an in-person Town Hall community meeting. We hope you'll agree, and I will reach out to your office to discuss further.

<u>Public comment on the letter</u>

Alice, Good evening. Thank you for writing the letter. It's super important that we have a town hall. It's way past time. You know we can do it outside, whatever, we have to do it. Thank you so much for your wonderful letter and for supporting that. I really appreciate it

Vice Chair Handron, thanks Alice. Does anybody have a motion to approve the letter?

Councilmember Cooper moved to approve the letter.

Councilmember Doss seconded.

Letter is unanimously approved.

Vice Chair Handron, the motion is to approve sending of the letter to Senator Mike McGuire and Senator Dodd with a change to the first bullet point removing, "has been assumed, and hoped for, and".

Councilmember Doss, Question regarding the process. I'm not familiar with how to address a letter like this. The parentheses around Senator Dodd, is that a technical issue or why is that happening? It kind of offsets him from McGuire. I'm curious about the grammar. I don't know the rule.

Councilmember Eagles, I honestly wasn't sure about the process either and if we would write two separate letters. I did not want to do two separate letters, so that was either to McGuire or Dodd but maybe this is where I'd ask you all the advice or Hannah's advice. I don't know what the protocol should be on this, so I would ask that we reserve the right to write to both of them or to one or the other or to combine the meeting. We will maybe take advice on that. That's all that meant: not wanting to do two letters. There will be a final version I assume.

Vice Chair Handron, I would think that you could do it in one of two ways, either have both of their addresses at the top of the page. One on the left hand side and one kind of in the middle of the page so that they're both together at the top and address it to both of them, or you can address it to one and do two different letters.

Councilmember Eagles, do we want two town hall meetings or just one big one and is that an appropriate thing to ask to two senators? This is what I don't know.

Hannah, what you're approving today is the content of the letter, so if it's a small change to the address or the two, I don't think that goes against your approval of the content of the letter. An open letter, part of that is because the MAC is an advisory body to the supervisor to the port of supervisors and not necessarily to the state, so they're phrasing it as an open letter, is kind of how we decide on that, so it's being sent to the supervisor as well. To the question you were asking is that what you're approving is the content, the body, and we can make small changes to things like formatting or address or things like that.

Bylaw Review: Appointments

- **Section 2. Appointment Authority.** The District Supervisor shall submit selected candidates to the Board of Supervisors for appointment. Appointments shall be posted in accordance with the Maddy Act (Government Code section 54970 ET seq.).
- Section 3. Terms. A membership term is a two-year period. North Sonoma Valley MAC members
 may be reappointed. Members may serve a maximum of two terms (4 years in total). No
 member or alternate member shall serve more than two years unless their appointing authority
 approves an exception to allow the commissioner or alternate commissioner to serve an
 additional term or terms.
- Section 4. Initial Terms. The Board of Supervisors shall classify the initial members into two classes. Class A shall consist of four members; Class B shall consist of three members. One Class A alternate and one Class B alternate shall also be appointed. Class A shall have an initial membership term of two years. Class B shall have an initial term of one year. Therefore, each member's term shall be two years. The district supervisor shall determine which member shall serve the initial two-year term.

<u>Q & A</u>

Vice Chair Handron, councilmember Doss represents the Kenwood areas, so are we looking for a replacement from the Kenwood area?

Hannah, I have that on my slide, correct.

Councilmember Doss, there's several folks who know I'm moving on and they may or may not submit an application. I don't know what their final decision will be.

Vice Chair Handron, is it appropriate to ask if those other council members whose term is expiring, if they are planning to remain? Kate, are you going to stay on?

Councilmember Eagles, I think I will. If people want to be on, I want to give people the chance to do this. I don't want to take anyone's spot who would like to do this for a while. You want to rotate folks.

Councilmember Nardo-Morgan, I agree with Kate on that. I would love to stay, but I would like to see you know more diversity, maybe a young person, give someone else an opportunity, but you know at this point we're kind of new and I don't know. I'm leaning towards staying at this point.

Vice Chair Handron, Hannah do people apply when there's not a vacancy? Do you have any applications?

Hannah, I believe we have two on file that have been received over the past year or two. It can be a more fluid process. Supervisor Gorin will consider any and all applications that come in, along with the intentions of MAC members who would like to continue on.

10. Reports and Announcements from Councilmembers and Ad Hocs Receive

Due to time constraints, the Chair requests this be limited to crucial or time sensitive items

Councilmember Nardo-Morgan, I would like everybody to know that it is Glen Ellen's sesquicentennial. Glen Ellen is turning 150 years old and so we put this together pretty quickly with the Glen Ellen Historical Society and the forum. We're going to have a little celebration on Monday night. That's the actual date that it turns 150 years old, June 20th. The Jack London Lodge has graciously given us their back patio. We would love every Community member near and far to join us. There will be light refreshments, a really big birthday cake, a no-host bar and we hope that you will come up with some memorable stories and whatever you want to do, a poem, a song, from our town there will be live music performed by Royal Jelly Jive. It's a free event, so please join us from 5:30pm to 9pm on Monday night. This isn't so much the ad hoc committee, but we did have a very lovely peaceful well-attended protest on the SDC property. A lot of press was there, it was really wonderful to see people come out and support. We were there because some developers were showing up and we wanted to make sure that they knew that the community really wants to be involved in the process.

Councilmember Eagles, It was Monday June 6th.

Councilmember Cooper, Arthur asked the transportation committee to comment. The two items were the Glen Ellen Pathway and Sonoma Valley Trail. We will be pursuing those two. I have a question, Ken Tam, who is the project manager for the Sonoma Valley Trail, which would involve all of the communities that we work with. I spoke with him and he'll be very willing to come on and bring everybody up to date with everything happening with that. Do we vote on that? Would everybody be interested in hearing him bring us up to date on that?

Councilmember Oldroyd, I'm interested in him coming.

Vice Chair Handron, that's a great idea. That would be our next agenda item.

Councilmember Oldroyd, Things that I've been looking at and talking to people about are safety items of roads, streets, and paths in Kenwood. The one that's popped up with importance for the community is

having a safe path from the Kenwood Depot to the town. There's a busy road and alongside the road there's no walkway. It's a steep drop off, so everyone is pushed into the traffic for like a half a block. More people would walk from the town to the depot rather than driving. Short distance, but dangerous.

Vice Chair Handron, Hannah is that something that we can incorporate into a future agenda item?

Hannah, I believe so. It may be something I can reach out to the ad hoc on to sort the conversation and bring back agenda items.

Councilmember Cooper, Can I just add that people are wondering why Boyes Spring has nice sidewalks and Kenwood has a number of streets that are difficult to walk on. A lot of people walk. We might expand that to something a little broader. You know, walkways in Kenwood.

Vice Chair Handron, I feel like I've moved rather quickly through the agenda and I don't want to rush anybody, so if there's any other other comments, announcements, or reports or anything.

Councilmember Doss, Yes I would like to inform everybody about an application called Watch Duty. It's a phenomenal free app, go to your app store and get it. It gives you instantaneous information about fire information, new fire, what's the status, who's fighting them, what equipment is on duty. In the last week, I don't know if you realize that we are in full-blown fire season. In the last two weeks, we had eight fires in our region. You would be amazed how this application comes on your phone and quickly gives you information about it. I would just recommend you to consider. If it makes you nervous, you don't want to know that much information, you can always turn it off. For me, for the fire department, as part of the fire district I like to know what's going on and this gives you information, pictures. There are so many cameras now around Sonoma and Napa County that within a minute or two you typically have a picture of the smoke of any new fire that's reported. The firemen watch it, they have it on their apps. It's quicker than some of the old systems that we have. It is a very fast application. Please share it with your friends because I think it's a really good heads up.

Councilmember Nardo-Morgan, Thank you so much for that information. I think it is really valuable. You said we're already on fire watch, it's June, which is so amazing and actually that's where Max is. He is out right now fighting fires, with the fire crew. He's an extraordinary young man so let's all think really good thoughts for him.

Councilmember Doss, Thank you for that. Good thoughts for Max. All the other teams are full speed right now they are 24/7 ready to go whether it be a small fire district like Kentwood or a larger one like CAL FIRE. It's pretty amazing how quickly Watch Duty sends an alert. Fire services have a different attitude now than they had five or six years ago. They respond very quickly, not only with fire equipment trucks etc. but with airplanes, helicopters. They're not waiting till it gets to be 10 acres, 100 acres, no, when it's a quarter of an acre that's big enough.

I've learned so much, especially about Kenwood and Glen Ellen. There's a big difference between the two and there are issues that are very important to each. I'm really glad that you're working together.

Vice Chair Handron, thank you for your service and contributions to the MAC.

Public comment:

Lori, this is for Councilmember Doss. I downloaded the Watch Duty app but it says, "allow Watch Duty to use your location" and then underneath it says, "allow once", "allow while using app" or "don't allow" and I don't know what to click on.

Councilmember Doss, I did, "allow while using the app".

11. Consideration of items for future agenda Receive

Vice Chair Handron, We have discussed the transportation ad-hoc having a further discussion with hopefully someone representing the Sonoma Valley Trail and the Glen Ellen Pathway. Any other recommendations for future agenda items?

Councilmember Doss, Is it appropriate for us to get information regarding new state park developments? There's a new park, new to me anyway, called Calabasas. It hasn't opened yet but it's going to open soon and it's over by botanical gardens somewhere in that area. I've never been in the park but it sounds pretty amazing and probably part of the wildlife corridor system too. How can we get information about state parks and how they run together and new ones that are being planned. I don't know if that's even appropriate for us, but I'm trying to think of something I know happening along Highway 12, between Glen Ellen and Kenwood.

Vice Chair Handron, Hannah I'll defer to you but it seems to me that's something that would be of interest to people who live in our area, hearing about state parks even though we're a county organization. Sharing the information about state parks is probably something that would fit within our purview do you agree?

Hannah, I think that's absolutely appropriate and sort of something parallel that I know the Springs MAC has had Caltrans come present about things about highway 12 to them, so having a state agency present an informational item is definitely something within your purview.

Councilmember Eagles, It was reported on about a year ago in the paper. In fact Christian is on but I know we don't have it agendied now, but looks like it has been on the cards, but maybe not formally opened yet. Christian from IT is on the line. Anyway we won't go there now, next time. Thanks.
