Current Status

July 2022 average award was \$7,437.92 per household (higher than recent months)

July 2022 had a 81.5% acceptance rate (higher than recent months)

About 1,548 ¹ cases remain to be reviewed.

Estimated cases that could be approved: 1,262 (=81% X 1,548 cases)

Estimated remainingERAP need: about \$9,400,000 (=1,262 x \$7,440 rounded)

Estimated Shortfall: \$4,118,000²

Reallocation of ERA 1 – US Treasury


- Sonoma County requested \$4.4 million

Reallocation of ERA 2 – US Treasury


- Sonoma County requested \$5 million

No other reallocations are anticipated. The State does not anticipate making any reallocations of State Round #1 or State Round #2.


Area Median Income (AMI) of Awardees




Awardee Ethnicity
