Dear Springs MAC members,

I have been in conversation with Suzanne Shonbrun. I believe many of you know and have worked with her. She filled me in on the history of the previous plans for the Springs corridor and a plaza.

While this is all very old information, some from as early as 1994, there are a lot of good ideas and observations in the documentation she gave me to read. Of course there are no longer state redevelopment funds, our demographics have changed, many businesses and buildings that existed then are no longer here in the Springs. But, one thing that stood out to me about past plans and ideas was that it was not really so much about commercial development, as it was about creating an environment for Springs residents.
