CALL TO ORDER, ROLL CALL Meeting called to order at approximately 6:02 p.m. Roll call was conducted by the Staff.

2. LAND ACKNOWLEDGEMENT

Commissioner Wood read the Land acknowledgement.

3. PUBLIC COMMENT ON NON-AGENDIZED ITEMS No Public Comment.

4. DR. KAREN MORANSKI PRESENTATION

Dr. Karen Moranski, the Provost and Vice President of Academic Affairs at Sonoma State University (SSU) presented on the future of SSU, and access for women to educational opportunities, which is the ultimate access to economic freedom. Her presentation covered issues that SSU is facing and the changes that they are creating for a better future. They currently have one of the lowest equity gaps for those students underrepresented and low-income students in the CSU; and they have among the highest 4 year and transfer graduation rates, however they have low enrollment due to the pandemic. They are making changes while cutting cost. They will continue to have a humanities program, but they will restructure with the limited budget and resources. Dr. Moranski is hopeful for the future of SSU. They are using some of the campus housing to develop affordable rental apartments for faculty and staff, where the rental prices include all utilities, internet, and cable. They are exploring hybrid learning and they received nearly \$600,000 in grants to support black students.

5. DR. VENUS OPAL REESE PRESENTATION

Dr. Venus Opal Reese introduced herself as the highest paid "spirit-led affluence" expert in the industry. She empowers people to success by transforming survival driven tactics to affluence creating messaging, marketing, high network client attraction and online automation. Her expertise comes from her experience. She was a homeless youth on the streets of Detroit. She learned tactics to keep her alive, that she spent a lifetime applying to creating her success. She eventually earned two bachelor's degrees, and a masters and doctorate from Stanford University. She touched on key points that can empower you change by being brave. Applying the bravery and perseverance we learn, especially as women, by surviving the traumatic experiences and touchy situations in our lives to new experiences that lead us on the path to affluence and success.

- e. Commissioner Jones-Carter announced that she was present when Tina Rivera presented on declaring racism as a public health crisis in Sonoma County and the meeting got disrupted by three gentlemen with different perspectives.

- g. Chair Fortino Dickson got invited to present at a panel for Women's History Month on March 23, 2024 in Geyserville along with Ariel Kelly and Laura Larque.
