# Introduction

The purpose of this report is to provide an overview of the work the Sonoma County Commission on the Status of Women (CSW) has provided to the County for the fiscal years 2023/24 and 2024/25.

# Mission and Vision Statement

The purpose of the Commission on the Status of Women is to promote equal rights and opportunities that enhance the quality of life for all women and girls, and to address issues of discrimination and prejudice that negatively affect women in Sonoma County.

We use our collective voice to influence decision-makers and empower the community to eliminate systemic barriers to full equity. We work to ensure women have social mobility, economic autonomy, reproductive freedom, and equitable representation in leadership roles.

We are advisors to the County of Sonoma Board of Supervisors and work to ensure that the issues impacting women and girls are given the necessary visibility to affect positive changes in public policy.

# Ad Hocs and Projects

# Report on the Status of Women and Girls Ad Hoc, 2023/2024

During the 2022/2023 fiscal year, the **Women's Recovery Response ad hoc** received a \$25,000 grant from the California Commission on the Status of Women and Girls (CCSWG) to identify and support the needs of women in California who have been disproportionately impacted by the COVID-19 pandemic. We then partnered with the Center for the Advancement of Women at Mount Saint Mary's University to produce the intersectional, advocacy-focused, 2023 Report on the Status of Women and Girls in Sonoma County. The Report draws on data from the Voices of Sonoma County Women 2021 research project and the September 2022 release of the U.S. Census Bureau's American Community Survey (ACS) to paint a comprehensive picture of the post-pandemic experiences of women in our county.

Our report was released in September 2023. Since then, we have undertaken several community-focused initiatives to share its findings and amplify its impact.

- With financial support from Sonoma County Community Grant funding, we translated the report into Spanish. This translation ensures that Spanish-speaking community members can access data-driven insights that spotlight challenges facing women in Sonoma County. By removing language barriers, we aim to build awareness and encourage engagement with the findings while directing attention to the organizations working to address these issues.
- Our work was featured in a podcast episode produced by the Sonoma County Administrator's Office. The podcast allowed us to share key findings with a broader audience and highlight the challenges identified in our research.
- We collaborated with community organizations on a social media campaign featuring data-driven insights that highlight challenges facing women in our County. The

campaign aimed to build awareness of key findings and amplify the work of local organizations addressing these issues and supporting women.

• On Juneteenth 2024, the Commission on the Status of Women hosted a breakfast to present the findings of the 2023 Report. The launch event brought together local organizations, community members, and elected officials to support effective policymaking and strategic planning. Former Chair Janice Blalock and Commissioner Ofra Isler led the presentation and provided a detailed overview of the report's key findings and contextual background. Attendees received flash drives with presentation slides in both English and Spanish. Hard copies of the full report were also made available. We had more than 30 organizations attend the event.

The 2023 Report on the Status of Women and Girls in Sonoma County is the culmination of three years of dedicated research, collaboration, and advocacy to uplift the voices of women and girls in Sonoma County. Through this work, we have provided a clear, data-driven understanding of the challenges women face, particularly in the wake of the COVID-19 pandemic. Our efforts to amplify these findings, including translating the report, engaging local media, collaborating with community organizations, and hosting events, reflect our commitment to ensuring that this work reaches diverse audiences and drives meaningful change.

# **Reproductive Health**

The Reproductive Health Ad Hoc in 2023-2024 was a follow up from the first year of this ad hoc. The year involved disseminating the information obtained during the pilot in Sonoma Valley, the findings from the pharmacy survey, and responding to requests for participation in community meetings related to the health and wellbeing of women and girls in Sonoma County. We were unable to transfer the pilot to other high schools in the county during this period but have composed a protocol for a second pilot in a Santa Rosa high school, with the participation of a college intern. We are translating the focus

group feedback into a survey format while adding more questions which will allow us to reach more young people. In addition, we are writing "targeted white papers" based on the feedback we collected in the first year and the recent Gender Policy Institute research on Access to Reproductive Health in Northern California. We will distribute these through social media and in our collaboration with community partners.

# **Reproductive Equity**

The Reproductive Equity derives from the Reproductive Health Ad hoc 2023-2024 and independent research from other sources on access to reproductive health. Specific Goals will derive from the Bay Area Access to Reproductive health research project (Gender Policy Institute) being published this fall and advocacy and outreach strategies around their findings, a revised high school survey built on what we learned two years ago in Sonoma HS, and updated pharmacy survey based on the OPILL and mifepristone.

# **The Junior Commission Educational Project**

The Junior Commission on the Status of Women is a program designed to provide mentorship to high school youth, preparing them for future leadership roles within our community. Students from across the county are invited to apply, with 15 - 30 selected each term to connect with mentors. In 2024 we had 30 students, which is double what we had the year previous.

Throughout the year, Junior Commissioners engage in a variety of activities, including roundtable discussions, career panels, community-based projects, and volunteer work. Participants are also introduced to important issues impacting women and girls through their ad hocs, such as healthy body and mind, menstrual poverty, lack of education, relationship violence, reproductive health and politics, and the complexities of hormones

and the female body. Recent career panelists have included professionals from a diverse range of fields, including lawyers, chemists, realtors, reproductive health epidemiologists, union leaders, apprenticeship coordinators, council members, and film actor/producers.

Additionally, in 2024 we had more in person meetings, as well as field trips and volunteer days (such as the Girls on the Run 5k). We have also begun teaming up with the Human Rights Youth Commission and combining our events. For example, in 2024 we joined their Unhouse Resource Learning Day, and they attended our Voting and Election Speaker Panel as well. These experiences help broaden the participants' understanding of various career paths and social issues, while fostering a commitment to leadership and advocacy.

# **Sonoma County Spirit Award 2023**

The Third annual Spirit Award theme was Building Bridges, Forging Unity. The winners displayed qualities of building bridges across divides of race, gender, class and politics to deepen empathy; has catalyzed and inspired collective action to make concrete changes in community and/or workplace conditions, policies, culture that resulted in greater equity and inclusion; Leverage their own power, privilege, influence and/or position to lift and amplify the voices of those in our community who are marginalized; and Inspire others and sets a clear example of cultural humility and respect.

# The winners for the 2024 Sonoma County Spirit Award are:

District 1: Maite Iturri, for her career as an educator and for the creation of Food For All/Comida Para Todos which provided nutritious and culturally relevant food to disenfranchised families and farmworkers in Sonoma Valley reaching into the county.

District 2: Dra. Mariana G. Martinez, for her leadership as an SRJC Trustee, as a

researcher, consultant around increasing access to education and as a personal mentor to many first-generation Latina college students in our community.

District 3: Alegria De La Cruz, for her meaningful work at the Office of Equity Department and her involvement in the County's American Rescue Plan Act Program: that is creating change from within our local government and the community at large.

District 4: Letitia Hanke, for her dedication in expanding horizons for youths, especially female youth of color, access to traditionally male dominated careers.

District 5: MaDonna Feather-Cruz, her advocacy for communities of color and for women. Her involvement in many Boards have helped articulate voices for the needs and history of Indigenous Californians and to help create a clear path to healing.

The award ceremony took place on March 9, 2023, during the Commission on the Status of Women regularly meeting location and time.

# **Sonoma County Spirit Award 2024**

The fourth annual award had all 5 of last year's recipients participate in the process of selecting the awardees for 2024. The 2024 theme was "Sonoma County Women & Girls Fighting for Equity, Diversity and Inclusion." The women selected demonstrated skills of working hard to better our community, even if they are not explicitly focusing on women and girls, because we know that racial justice work, work to protect labor rights, work to empower immigrants, work to improve accessibility, and all other social justice efforts benefit women and girls of all backgrounds.

# The winners for the 2024 Sonoma County Spirit Award are:

District 1. Phyllis Rosenfield – Her life work shows her commitment and contribution to the mission of Listening for a Change: to promote understanding and acceptance of human diversity through education, oral history, and the arts.

District 2. Hanan Huneidi – She is a fierce advocate for the LGBTQIA2S+ community here in Sonoma County. She founded Petaluma Pride and made its work possible.

District 3. Belen Lopez- Grady - embodies the values of the Sonoma County Spirit Award. Belen is a strong woman of color who is currently the Executive Director of North Bay Organizing Project which advocates for the rights of tenants, immigrants, and promotes language justice.

District 4. Marcy Flores- Her commitment to community change is evident in every area of her life, professional and personal. As executive director of Corazón Healdsburg, a mission-driven human-rights organization, Marcy leads the agency's multiple programs including a bilingual resource center deeply trusted by the Latino community that offers family-centered case management and takes a cradle-to-career approach to education for all ages.

District 5. Lupe Catalan - is a Bilingual Field Representative for District 5. Prior to working for the district. Lupe worked as a Promotora, connecting West County residents to critical medical resources and services. She worked with both WCHC and Cafecitos to empower Latina mothers to engage in and advocate for their child's education.

On January 21, 2025, the group hosted their first event Room Full of Referrals at 9am-1pm at 3033 Cleveland Ave, Santa Rosa. Room Full of Referrals workshop taught individuals to communicate effectively with clients, coworkers, and loved ones through the DISC technique.

# Sonoma County Human Trafficking Task Force (SCHTTF)

The Commission on the Status of Women appointed former Chair Janice Blalock to continue serving as our liaison to the SCHTTF as she has for the past 9 years. Meetings take place at the Family Justice Center. The Task Force includes partners from Law Enforcement, the D.A's office, Sonoma County Department of Human Services ,service providers such as Verity, Polly Klass Foundation and Redemption House of the Bay Area and Community organizations such as Soroptimist's, Jr League, CSW and CHR. The mission of the task force is to collaborate on eradicating Human Trafficking in Sonoma County and to educate the community on what trafficking is and how to recognize it.

# **CSW Legislative Committee**

Each member of this committee monitors the legislative program/agenda of groups with a similar focus, i.e., issues confronting women and girls, protection of women's rights, and women's wellbeing. Members monitor bills introduced in the state legislature, assess, and report back to the Commission. The Commission discusses and authorizes writing letters, communicating with local legislators, or partnering with groups in advocacy in support or opposition to the legislation.

# League of Women Voters Sonoma/Marin

On October 10, 2024 The Commission on the Status of Women collaborated with League of Women Voters Sonoma/Marin and the Commission on Human Rights to provide a presentations on a non-partisan and unbiased look at the Pros & Cons of the ten state ballot propositions and three Sonoma County-wide measures that will appear on the November 5, 2024 ballot. The presentation helped demystify the ballot and explain what a "yes" vote means and what a "no" vote means.

The Commission is a strong supportive of 4C's mission and they have continued their partnership. On August 26th, the commission attended their 50th Anniversary Event "Champions for Children" to show support. CSW paid \$1,000.00 as sponsorship to attend.

In 2023, the Women's Recovery Response ad hoc received a \$25,000 grant from the California Commission on the Status of Women and Girls (CCSWG) to identify and assess the needs of women in Sonoma County who have been disproportionately impacted by the Pandemic. This information was incorporated into a statewide report. The report was translated into

Spanish and disseminated broadly including through podcasts, a social media campaign, and a Juneteenth 2024 Community breakfast in which community representatives were invited to review and discuss the findings. Each participant received an electronic copy of the report to share.

Data was gathered about obstacles faced by women and girls in specific priority areas such as the Reproductive Health including findings from interviews with pharmacist's county wide about access to OTC contraceptives.

The Junior Commission on the Status of Women is designed to provide mentorship to high school youth, preparing them for future leadership roles within our community. Students from across the county are invited to apply and in 2024, 30 students were selected, which doubled the number of participants in prior years. The Junior Commission mirrors the adult Commission with monthly meetings and ad hocs, but Junior Commissioners select projects of most interest to them and completed projects are presented to the Board of Supervisors at graduation. The Commission began collaborating on community events with the Human Rights Youth Commission, e.g., the Unhouse Resource Learning Day, the County Voting and Election Panel. These experiences help broaden the participants' understanding of career paths and social issues, while fostering a commitment to leadership and advocacy.

The theme for the Third Annual Spirit Award was Building Bridges, Forging Unity. The winners (one from each District) were selected through recommendations from friends, neighbors, coworkers. The nominees were screened by prior award winners based on displaying qualities of building bridges across divides of race, gender, class and politics to deepen empathy. Recipients included educators, community organization leaders, farm worker activists, business leaders working in nontraditional employment, and elected officials in higher education.

Collaborating with community organizations and county wide initiatives has been a core function of the Commission. In 2023-20245 these partnerships continued and expanded. CSW has been represented on the Sonoma County Human Trafficking Task Force since its formation. Partners included Verity, League of Women Voters, 4 C's

Annual Champions for Children, Sonoma County Pride, Women in Conversation, Los Cien, YMCA Run, Translife, Positive Images, LGBTQ Connection, Landpath, Cinco De Mayo Festivals. In addition, the Commission annually reaches out to local government and the County to secure Proclamations from each celebrating Women's History Month and Women's Equality Day.

At the CSW biannual strategic planning meeting, projects for the next two years will be discussed and prioritized, and budget allocated. The Commissioners look forward to being even more visible in Sonoma County, collaborating with other Commissions on shared issues, and increasing our capacity to identify the everyday issues of greatest concern to women and girls in our County. As we all know, the concerns, needs, challenges which effect women have a broad impact on the wellbeing of the entire family, and consequently, the wellbeing of the entire County.
