 didn't take the case of David Pelaez Chavez. CAC also received an email from Keith
 Rhinehart sharing support for CAC.

3. Director's Report

 Director Alden reported on the Community Engagement Manager Lizett as supporting the CAC meetings from now on. Lizett had an interview on KRCB radio. Mentioned the lovely reception CAC had for John last month. First ever Race &

Equity training for dept heads was hosted by Dept of Race & Equity here in Sonoma County. 2nd Jail tour to be scheduled and will accompany some of the CAC members. John attended and spoke at the Human Rights Commission meeting. John shared about having contact with neighboring counties about creating a Sheriffs Oversight in SF, Mendocino, and Marin. We continue to working with the Sheriffs Office with audits. We were able to attend Dia de los Cien. IOLERO is hiring for an Auditor on a rolling basis. NACOLE has been doing their Virtual trainings. NACOLE trainings will be available for future use. IOLERO has received direction as to future CAC meetings and County Counsel will have more advice as to how CAC meetings will be run in 2023. We are looking for spaces for those future in-person meetings. Lastly, the 3 issues with the Letters of Agreement concerns that the CAC has regarding the Whistleblower issue, we are working on hiring the Auditor which will help with that concern. 2nd issue IOLERO can issue a subpoena to the Sheriff's Office and the expectation is that the Sheriff's Office will comply unless there is a legal issue. 3rd issue is the timing of when IOLERO starts their independent investigation where use of force or an in-custody death is still in process.

• Lizett shared announcements. January meeting will be changed from January 2nd to January 9th due to the county holiday. 2nd Jail tour to be scheduled after Thanksgiving break. CAC members should have already received an email from Sonoma Higher Ed regarding trainings for Diversity, Inclusion, and Equity.

RE: Your letter dated October 18, 2022 regarding the fatal shooting of David Palaez-Chavez by Sonoma County Deputy Sheriff Michael Dietrick on July 29, 2022

Dear Mr. Bonta & Mr. Root:

We thank you for your letter dated October 18, 2022 explaining why the California Department of Justice declined to undertake its statutory obligation under AB 1506 to investigate fatal shootings by law enforcement by "unarmed" citizens. Unfortunately, we find your explanation unconvincing.

We are well aware of the protocols and bulletins available on your web site. What your administrative protocols and your letter fail to address, however, is the totality of your obligation to investigate, which includes where "there is a reasonable dispute as to whether the civilian was armed." Calif. Gov't Code §12525.3(b)(2)(A). As you acknowledge in your letter, Mr. Palaez-Chavez "appeared" to possess a rock. That appearance is just that — an appearance — and deserved more investigation to determine whether this ordinary object, indeed, was (a) to be used as a weapon, and (b) was "deadly." Some basic questions such as how much the rock weighed, how far it could be thrown by a person who had just run barefoot for 45 minutes, how far the deputies were from Mr. Palaez-Chavez at the time of the shooting, need to be answered before such a determination could be made. Your office did none of that.

While you may "expect that a thorough and impartial investigation and review" will be conducted by local authorities, many in our community find that expectation unreasonable in light of the history of investigations into fatal shootings by law enforcement in Sonoma County. Indeed, AB 1506 was passed because that expectation was unreasonable given the inherent bias and conflicts of interest when one local law enforcement agency investigates another.

We are disappointed in your response to our request and ask you to reconsider your decision.
