Subject: Summary of Applications Received for Fiscal Year (FY) 2023-2024 Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), Emergency Solutions Grant (ESG), Low- and Moderate-Income Housing Asset Fund (LMIHAF), and FY 2020-2021 CDBG Cares Act (CDBG-CV)

Application Summary

The annual FY 2023-2024 Notice of Funding Availability (NOFA) was published on December 7th, 2022, requesting applications for eligible capital projects, affordable housing projects, tenant based rental assistance, supportive services, fair housing, non-congregate shelter and economic development activities. The Sonoma County Community Development Commission (CDC) staff held two virtual Technical Assistance (TA) sessions for prospective applicants on December 15, 2022, and December 19, 2022. Attendance at one of the two TA workshops was mandatory or could be substituted for a one-on-one TA meeting with the CDC staff. There were approximately 45 attendees at the TA sessions which included a presentation of application requirements, eligible activities, fund sources available and concluded with an opportunity for attendees to present questions and obtain responses from staff. CDC staff also provided technical assistance individually to many prospective applicants before, between, and after the two TA sessions. Applications were originally due to the CDC on January 11, 2023, however, the submittal deadline was extended to Wednesday, January 25th at 5:00 PM. The application submittal due date was extended due to the declared state of emergency as a result of weather conditions and events during the week of the original deadline. Many CDC staff and community-based organization staff were temporarily engaged in emergency operations and supportive services during this period. Table 1 lists the applications and CDC administered program funding requests that were submitted in response to the NOFA.

Based on the funding requests for each category, with the exception of the HOME CHDO funds, the total amount requested exceeds the amount available. The funding amounts for FY 2023-2024 are estimated as the U.S. Department of Housing and Urban Development (HUD) has not published the FY 2023 CDBG, HOME, and ESG allocations, which are based on the adoption of a federal budget enacted by Congress. The estimated amounts are based on prior year amounts received by Sonoma County. There may be additional CDBG and HOME funds available from prior years and from program income received that must be reprogrammed that will be added to the total funds available with the application materials included in the March committees' agendas. These updated amounts will increase the total amount available to allocate to new activities and funding applications.

CDC staff are conducting a review and evaluation of the applications received to determine completeness, eligibility for the funding requested and conformance with the FY 2023-2024 Funding Policies approved by the Board of Supervisors on December 13, 2022. A staff analysis of each application will be prepared for the March 15, 2023, meeting of the CD Committee and Cities and Towns Advisory Committee, which will be conducted in a workshop format. At the workshop the committees will review staff analyses of proposals submitted under the competitive funding categories, take testimony from applicants, and provide feedback to staff that will be integrated into the draft FY 2023-2024 Action Plan and FY 2020-2021 Action Plan Substantial Amendment. All applicants must be present at the public workshop to be considered for funding.
