### 2. Public Comments for Items Not on the Agenda

**3.** Approval of September 20, 2023, 2023 and November 15, 2023 Meeting Minutes Approval of the meeting minutes was continued to the next meeting due to a lack of quorum to approve them.

## 4. Fiscal Year 2024-2025 Annual Action Plan Funding Recommendations

Valerie Johnson and Veronica Ortiz-De Anda, CDC staff, presented the funding recommendations for Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME) program, Emergency Solutions Grant (ESG), HOME American Rescue Plan Act program (HOME-ARP), and Low-Moderate Income Housing Asset (LMIHAF) funding program. After the presentation staff answered questions from the committee.

#### **Public comments:**

Public comments were made by several applicants regarding their respective funding application and they answered questions from the committee.

Chair Svanstrom expressed her desire to fully fund Fair Housing Advocates of Northern California (FHANC) their full request of \$130,000 CDBG funds and reduce the request of Legal Aid of Sonoma County (Legal Aid) accordingly. Committee member Sotomayor commented on the importance of the services that both organizations provide. The Chair moved to approve the funding recommendations as presented by staff subject to funding FHANC their full request of \$130,000 and thereby reducing the funding recommendations to Legal Aid to \$125,956. Committee Sotomayor seconded. Committee member Streeter asked a procedural question and staff answered. After further discussion, Chair Svanstrom withdrew her motion.

The committee deliberated on the different funding recommendations and designation of a contingency project. CDC staff provided further clarification on the purpose of designating a project as "contingent".

Committee member Streeter moved to approve the funding recommendations as presented by staff subject to changing the funding recommendation of FHANC to \$130,000 and thereby reducing the funding recommendation to Legal Aid to \$125,956; and designating Burbank Housing's application for Elderberry Commons as the contingency project instead of Saint Vincent de Paul's application for Gravenstein Commons Affordable Housing project under the HOME program and was seconded by Committee member Thompson.

Committee member Streeter moved to approve the funding recommendations as presented by staff subject to designating Burbank Housing's application for Elderberry Commons as the contingency project instead of Saint Vincent de Paul's application for Gravenstein Commons Affordable Housing project under the HOME program and was seconded by Committee member Gates.
