5. Interim Director's Report

Tina Rivera provided an update on Federal and State funding opportunities, as well as Community Development Commission staffing. Barbie Robinson will become the public health director for Harris County, Texas as of May 21, 2021. Staff will keep the committees updated on leadership transition plans.

The Community Development Commission (CDC) has promoted four staff to positions

within the department and is hiring two additional staff. CDC has also hired three administrative aides, a department analyst, and a supervising accountant. Recruitment to fill other vacant positions is in progress. Staffing changes are noted on CDC website.

CDC staff is working with Housing and Urban Development (HUD) staff on the processes and timeline for the consolidated NOFA. Staff to meet with the state for CDBG-DR and will update the CDC website and distribute an email announcement when timing is known.

Rohish Lal, Legislative Policy and External Affairs Officer (Department of Health Services), provided an update from the California Department of Housing and Community Development (HCD) on Senate Bill 5, the Affordable Housing Bond Act of 2022. Amendments would authorize \$6.5 billion in bonds pursuant to state general obligation for affordable rental housing and home ownership programs. HCD also announced the multifamily housing program and the infrastructure grant program will both be ending. Lastly, the HCD has posted Round 6 guidelines for the Affordable Housing and Sustainable Communities (AHSC) program with an amendment to CDBG for Coronavirus response for Round 2 guidelines.

HUD has allocated \$1.25 billion for tribal housing programs as follows:

- \$498 million for home owner assistance program
- \$450 million for Indian house block grant
- \$280 million for Indian community development block grant
- \$15 million for technical assistance.

HCD is working on the next infrastructure bill, likely for \$1 trillion, to be confirmed during summer 2021.

Tina Rivera gave an update on HUD emergency rental assistance. Sonoma County has received \$14.7 million to date and is eligible to apply for an additional \$16 million. The CDC has opted to administer its own program and is currently conducting community outreach among relevant organizations, stakeholders, and the Board of Supervisors. CDC is also working with vendor that designed software specific to this program, available in several languages. Acceptance of these federal rental assistance funds and authorization of program development will go to the Board of Supervisors on April 6, 2021.

Stephen Sotomayor made a motion requesting monthly meetings with Santa Rosa and Petaluma about the rental assistance program. Kari Svanstrom seconded.

Subject: Award of Project Based Vouchers

The U.S. Department of Housing and Urban Development (HUD) allows Housing Authorities to attach up to 20% of its Section 8 Housing Choice Voucher program funding to specific housing units by project-basing vouchers. With this award, the Housing Authority will have project based 12% of its Housing Choice Voucher program. In contrast to the tenant-based voucher program, project-based housing subsidy remains with the unit after a tenant moves out. The owner must agree to rent the unit to eligible tenants for the duration of the Housing Assistance Payments (HAP) contract, which is often up to 20 years. After residing in a project-based unit for one year, a tenant may request to transfer to the Housing Choice Voucher program. If a voucher is available, the Housing Authority will allow the tenant to transfer programs and move with continued assistance.

In 2017, the Commission released a rolling application for homeless-dedicated Project-Based Vouchers available to property owners and developers. In response to the Request for Proposals (RFP), two applications were received requesting a total of 14 project-based vouchers. Applications were reviewed by Community Development Commission staff to ensure that each met the criteria outlined in the RFP. Each of these projects meet the goals of increasing the affordable housing stock within the County, providing affordable housing in areas outside of poverty concentration, and providing housing in areas that are transit-oriented.

Staff are requesting the Committee's review and recommendation of award of PBVs to the projects listed in this memo. With these vouchers, the Housing Authority will have committed 12% of its Housing Choice Voucher program (348 vouchers) as PBVs.
