- **1. Welcome & Introductions (Helman)** Meeting called to order at 1:02 PM all welcome and introductions made.
- 2. Approval of February 2021 Advisory Council Meeting Minutes (Helman)
  - (Motion) Reynoza/Black (MSC) to approve February 17, 2021 Advisory Council meeting minutes. Approved Unanimously. AYES 15, NOES 0, Abstentions 0
- 3. Requests for Proposals (RFP) Funding Recommendation (Spain/Repp)
  - Review of Funding Recommendations
  - Public Comment
    - John Pavik (Catholic Charities) Read letter out loud from Helen Metzger in support of Alzheimer's Day Care Program
    - Marrianne McBride (Council on Aging) Comment on funding for Adult Day Program funding. Council on Aging has increased the number of clients across 4 sites over the last 3 years. It will be difficult to maintain the program with level of funding in the recommendation.
      - Additionally, they see a huge need for Alzheimer's Day program. Advocates for funding the program
    - Couch (Ceres Community Project) Ceres provides medically tailored meals for very lowincome clients. Went from 1600 to 5400 meals per week over the course of 2020. Amount recommended for funding (19% of request) would end up being 2% of need for the program to run.

- Dombrowski (Alzheimer's Association) Thanks Advisory Council for funding. Acknowledges comments about Alzheimer's Day program and expresses concerns for the clients who need Alzheimer's Day services.
- Powers-Stone (Redwood Caregiver Resource Center) Expresses support for Alzheimer's Day Care program to be funded.
- Swan (Catholic Charities) Expresses support for Alzheimer's Day program at Council on Aging. AAA Funding is vital core funding that is supported by other partner funding to support the program.
- Cimino (Petaluma People Services Center) Expresses appreciation for the funding for PPSC's programs
- Advisory Council Comments
  - Rice Asked for clarification of the process of evaluation
    - Explanation of the process Proposals read and scored by Proposal Review Committee. Proposal scores and staff funding recommendations are provided to Planning & Funding Committee for consideration for funding. Planning & Funding reviews, modifies if necessary, and approves funding recommendations. Planning & Funding recommendations brought to Advisory Council for final review and approval.
  - Dunaway addressed the Council on Aging proposal for Alzheimer's Day Program; it scored high enough for consideration but needed additional details on how program would be provided in person. Program could be funded at a later date.

  - Serkissian has conflict of interest with Transportation Funding Recommendation
- (Motion) Rice/Black (MSC) to approve the Funding Recommendations for Older American's Act contracts with proposers from Request for Proposals. AYES – 14, NOES – 0, Abstentions -1

- Capitol Day
  - Met with Congressperson Thompson on Feb 25. Congressperson very engaged and interested in AAA programs (formerly worked for a AAA)
- American Rescue Plan
  - Additional round of federal emergency funding is coming. Unknown the amount of allocation
  - Increases to Nutrition Programs, APS, Housing and Homelessness
- Vaccines
  - 206,000 vaccinations provided in Sonoma County to date
  - Supervisor Gorin has held 2 older adult service forums on vaccines
- Great Plates Delivered
  - Began in 2020: a program where older adults are provided restaurant meals. Sonoma County declined initially as county cost too high. Possibility that program will be reimbursed at 100% by FEMA, which could allow Sonoma County to join program
- Aging Together Workgroup
  - Restructuring around the core pillars of Aging Together

- Beards Concern about council going into breakout rooms on Zoom to talk about a funding decision
- McBride Interns have been calling 3000 older adults on their program list to see if they face any barriers to vaccine. Helps to secure transportation for vaccines

- Finnigan March is Older Californians Nutrition Month. Recognition for our providers for their work during the pandemic and beyond
- Davis (SASC) Thanks council for funding transportation services. 95% of staff and volunteers are vaccinated. Looking forward to meeting with County for guidance on reopening
- Zappa The Center for Social and Environmental Stewardship (CSFES or The Center) will be changing their name officially to Circuit Rider Community Services
