Innovation projects:

- Instructions Not Included (Provided by Early Learning Institute)—home visiting program for first time fathers, screening for Adverse Childhood Experiences ACEs) and depression and providing referrals.
- New Parent TLC (Provided by First 5 Sonoma County) gatekeeper training for early intervention of maternal and paternal mental health issues.
- Nuestra Cultura Cura Social Innovations lab (Provided by On the Move/VOICES)-a partnership of community organizations will engage a diverse cohort from the Latinx communities to determine root causes of mental health stigma and inaccessibility for their communities.
- Collaborative Care Enhanced Recovery Project: Advancing Older Adult Depression Dare through Extended Supportive Services (CCERP) (Provided by Sonoma County Human Services Adult & Aging and Santa Rosa Community Health Center)-combines an established short-term 12 week intervention with 9-months of in – home case management, to improve outcomes for adults from 50-64 years old with depression.
