4. Budget Update—Chief Koch & Brad Hecht

(handout)

Changes since June 8, 2020.

- The CCP needed to cut a minimum of \$1.5 million dollars from FY 20/21. The CCP actual cut was approximately \$2 million dollars, which put the out years in a better position.
- The State Realignment backfill projection would add an additional \$995k to CCP and \$32k to DA/PD in FY 20/21.
- Underspending of FY 19/20 funds (nearly \$1.3 million)
- CCP State revenue. May revise estimated \$1.152 million. Actual receipts through July \$1,222 million.

These numbers are encouraging; however, these are initial early trends of revenue. Underspent money will go back into the reserve.

5. <u>Transitional Housing Funding Request—Chief Koch</u>

A request to restore some of transitional housing resources, which amounts to approx. 153k. This request is being made in response to inmates coming out of CDCR who are on accelerated release, as well as those inmates on natural release dates.

Darren Fravel: Anticipate 40 PRCS inmates through the end of the year, of which 15-20 in the next couple of weeks.

Chief Koch: Approximately 50% will require transitional housing. Additionally, Deputy Chief Perry and Division Directors have worked with Bill Carter with those released inmates that test positive for COVID-19. These released inmates require special housing placement.

In response to the additional released inmates, Chief Koch asks that the CCP approve expenditure of an additional 153k to fund additional beds through IFSN.
