Board Comment:

Chris Coursey: clarified whether or not the budget chart was included in the meeting packet. Tom Schwedhelm: Is the goal to get the money spent? Would like more information on spending plans and organizational capacity to spend down quickly.

Discussion ensued on planning for the remaining funds to ensure that all funds are expended.

Board Comment:

Don Schwartz: readdressed the SAY funding question. Asked for clarification on \$89,000 from HEAP interest. Proposed that SAY receive \$20,000 from PEP & \$20,000 from SVDP.

Discussion ensued on HEAP interest and moving funds by the spending deadline.

Don Schwartz: withdrew suggestion. Based on HEAP interest discussion. Jennielynn Holmes: Can we ask SAY if they would be able to expend funds by deadline?

Lis Fatu: clarified that the interest dollars were considered for FY 21/22. The dollars SAY asked for was for street outreach and shelter. Funds would be used to on salaries, wages, and shelter supplies. The interest will be used next fiscal year. Would be able to expend funds by June 15, 2021.

Bill Carter: how much money would be able to be spent?

Funds can be used retroactively or moving forward.

Ludmilla Bade: The interest funding available in July, are agencies willing to switch the allocations? Chris Coursey: It is not on the agenda to discuss other funds.

Don Schwartz motioned to approve the committee's recommendation with an amendment to remove \$ 10,000 each from the St Vincent de Paul and PEP Housing projects, totaling \$20,000 and allocate it to Social Advocates for Youth. If the state doesn't approve these changes within the application for the services, all the funding would go to the St Vincent de Paul project; including any additional HEAP funds that would not be spent by the deadline; Tom Schwedhelm seconded.

Board Comment:

Bill Carter: what is the rationale for taking the funding away?

Don Schwartz: explained urgency of fund distribution and thinking.

Jennielynn Holmes: if state doesn't approve any of the funding allocations, funds would default to

Saint Vincent de Paul?

Ludmilla Bade: offer amendment of \$20,000 to SAVS outreach. With 15k being taken from PEP and SVDP. Bill Carter: would defer to committee.

Angela Struckmann: recommend to keep committee recommendations. Would there have to be another request for the approval of non-capital projects?

Don Schwartz withdrew the motion.

Don Schwartz motioned to accept the committee recommendations, with one exception, to reduce to \$20,000 total funding to SAY (\$10,000 from PEP/SVDP). Any remaining HEAP funds that become available, either because the state does not accept the amendment to allocate funds to services or any additional projects that cannot spend HEAP funds, would be to allocate the remaining funding

with \$10,000 to PEP Housing and the remaining to the St Vincent de Paul project; Tom Schwedhelm seconds.

4. Recommendation for Strategic Planning and Charter Review Committee Membership (1:19)

Jennielynn Holmes provided recommendations for Strategic Planning Committee and the Charter & Policy Review Committee. The recommendation is to split into two committees: the Strategic Planning Committee and the Charter & Policy Review Committee. Chair Ben Leroi and Co-Chair Jennielynn Holmes worked to ensure that all committees did not have a quorum and maintained diverse experiences.

Board Comment:

Chris Coursey: Challenge of having an even number of committee members in regard to passing votes. Ludmilla Bade: Is there a list of the applicants? Would be interested in seeing it.

Tom Schwedhelm: Looking for a regional plan from the strategic committee and an 11th person could be a representative from the county.

Don Schwartz: Concurred with Tom and importance of working with Board of Supervisors for the regional plan. Oscar Chavez is willing to serve on the committee, he is already on the Community Development Committee.

Jennielynn Holmes: Supportive of adding someone from the county. Not sure of the process, but it can't be a county member from the board to avoid quorum.

4. Homeless Emergency Solutions Grant (ESG) COVID-19 Update (8:00)

Michael Gause provided an overview of a staff recommendation for the updated ESG-CV funds and discuss the required expenditure deadline and a staff recommendation for spending the \$4,737,799. Funds are eligible for retroactive spending from March 2020. A minimum of 40% of the eligible funds must be spent on Rapid Re-housing programs (\$2,107,475) and the remaining 60% (\$3,628,712) may be spent on both congregate and non-congregate emergency shelters. The first 20% spending benchmark is July 31, 2021. A second 20% must be spent by September 2021. All funds must be expended by September 2022.

Staff recommendation is to distribute the initial 20% across the emergency congregate and non-congregate shelters who have incurred costs due to the COVID-19 pandemic. Funding would be split evenly among all shelters. Staff recommends that a work group is initiated to determine how to spend the remaining ESG-CV funds.

Board Comment:

Board discussed the staff recommendation and determined that there was not enough information to make a decision on funding and that a workgroup should be formed.

Supervisor Chris Coursey volunteered to be interim chair.

Kevin McDonnell motioned to fund all of the listed and unlisted emergency shelters on the basis of population served, Don Schwartz seconded.

Don Schwartz: There are meant to be unfunded but related costs with no federal or state funding received, to include FEMA reimbursement for FEMA related costs. We are ensuring that dollars fo to organizations that have not received COVID related funding. 60% of the first 20% should go to the shelters and the remaining 40% to Rapid Re-housing. The funding decision should be based on unfunded COVID costs and occupancy.

Stephen Sotomayor: I do not support making a decision today.

Stephen Sotomayor motioned to get more information from staff, via a work group, on incurred costs prior to making a funding decision, Alena Wall seconded.

Kevin McDonnell: There is a benefit to getting the spending started now while also relying on a work group to strategize and research for the remaining funds. We need to make decisions and utilize the work group. I withdraw my motion.

Ludmilla Bade: I would prefer a 2/3 expenditure from Kevin McDonnell's recommendation.

Kevin McDonnell: We need to vote on this then open it back up and have the entire group vote on the plan to get a work group for the remaining funding.

Don Schwartz: We need to refer to the work groups as Ad-Hoc Committee meetings.

Ludmilla Bade: I would like to see a broader eligibility beyond shelters.

Bill Carter: Would this process jeopardize the funds?

There is a work group working on Rapid Re-housing standards and I would like a report from the group to come to the full board as soon as work is done We need to know how the providers are doing.

Tom Schwedhelm: Recused members should have been brought back as soon as Kevin McDonnell withdrew his motion.

Kevin McDonnell: we need to come up with a specific task for the upcoming ad-hoc group. The 40%/60% split can be a task of the work group and how they intend to solicit the funds.

Ludmilla Bade: I would support a letter of intent going out as soon as possible.

Kevin McDonnell motioned to create an Ad-Hoc committee with open meetings to the public, to determine expenditures of the remaining 80% of the funds, that the group be co-membershipped by the initial work group, and determine a process and recommendation for the spending to bring back to the full board, Chris Coursey seconded.

Kevin McDonnell: my motion is to make the work group the same as the initial one so a modification to the motion would have to be made. The process for the work group should include welcoming voices and have mechanism to include providers on the calls.

7. Report on Continuum of Care Renewal Evaluations from the Ad Hoc Committee

Karissa White provided an update on the Continuum of Care Competition Evaluation meeting and site visits with participating agencies. The Ad Hoc group met on May 17 and May 24, 2021 to review the Program Renewal Application materials for all 15 projects. Site visits are currently underway and the committee will meet in June prior to the Continuum of Care Board meeting to finalize the scoring and

make a recommendation to bring back for the boards consideration. Michael Gause thanked the committee members.

8. Update on Emergency Housing Vouchers

Martha Cheever, Housing Authority Manger for Sonoma County, and Rebecca Lane, Housing Authority Manager for the City of Santa Rosa presented on the upcoming available Emergency Housing Vouchers (EHV). 150 EHV's have been provided to the County of Sonoma and 128 EHV's have been allocated to the city of Santa Rosa. Additional vouchers may become available. The goal of today's session is to facilitate the beginning of a recommendation for target populations. The Memorandum of Understanding needs to be signed no later than July 31, 2021. The Housing Authority also identifies it as a top priority to connect with the Lived Experience Advisory Board.

Board Comments:

Jennielynn Holmes: This has so much opportunity to initiate the system change we want. I recommend utilizing the Coordinated Entry Assessment Committee as it is already a public meeting.

Tom Schwedhelm: Echoes Jennielynn's excitement, but thinks that this should be a separate committee. Also clarified that two separate MOU's will be signed, so the board can recommend more than one target population.

Margaret Sluyk: Is it possible to use funds for Permanent Supportive Housing populations?

Kevin McDonnell: What is the housing availability?

Ludmilla Bade: Will there be a program beyond the applications? Are vouchers released through the lottery system? We are hearing about the mismatch of resources with the lack of wrap around resources.

Jennielynn Holmes: Would be interesting to see ESG-CV funds also support this. We have a real opportunity to end homelessness in sub populations with this opportunity.

Ben Leroi: Can you confirm that we can use the ESG-CV funds for this?

Don Schwartz: What is the timeline and time limit on the vouchers? It is critical that we establish a relationship with the realtor/landlord community. Requested the slides so that board members can extend through their communication channels. Also curious about the plan to provide continual case management. Jennielynn Holmes: If the vouchers cover the leasing there is a potential to repurpose the funds for case management.

Don Schwartz: Room to amend Measure O dollars via the Board of Supervisors.

9. 100 Day Challenge for Homeless Youth (3:45)

Meghan Murphy and Martha Cheever presented on the 100 Day Challenge which was a County wide initiative. In 100 days, the goal was to connect 65 Transitional Aged Youth to housing with a focus on the LGBTQI+ population and BIPOC youth. The 100 Day Challenge also helped to reimagine the homeless response system in order to ensure housing accessibility to the maximum number of youths. Post challenge, 59 youth moved into stable housing. There are 32 remaining housing vouchers that are looking for housing or still in process of procuring the voucher. In total, 91 transitional aged youth were impacted by the challenge. The constraints in the system were identified as follows: capacity restraints, lack of housing stock, and limitation of the HUD definition of homelessness.

The methodology included interviews, comparing counties homeless and housing programs to create a 160 page report with 27 recommendations and 95 action items. The recommendations and action items are filed into ten buckets: program enrichment and integration; program optimization; Coordinated Entry; coordinated service delivery; housing coordination and access; system support and enablers; system and data usage; training and capabilities; strategy structure and funding of governance, organization structure, and funding optimization. The goal is to find a model for the county to collaborate and build tools.

Agenda Item Overview

In this item, the ESG-CV Working Group provides a recommendation to the full CoC Board for allocation of 20% of State ESG-CV funds prior to the first expenditure deadline of July 31, 2021. Previously, the CoC Board directed the work group to bring back a spending recommendation for the first 20% of the ESG-CV 2 funds. The ESG Working Group of the CoC Board met on June 14 to discuss the initial spending plan of \$1,155,577 that must be spent by July 31st, 2021. The group received research from staff on all emergency shelter/non-congregate shelter incurred costs in Sonoma County and opened the meeting to public comment. The breakdown is as follows: a total of \$504,333 to emergency shelters and \$651,224 to the City of Santa Rosa to cover capital expenses for the Sam Jones Hall annex. There is a contingency plan that if any organization has trouble spending down by July 31st, the funds will go to the Sam Jones Hall annex.

Agenda Item Overview

The Coordinated Entry Advisory (CEA) Committee met on May 28th and again on June 11th to discuss prioritization of Emergency Housing Vouchers with the Sonoma County and Santa Rosa Housing Authorities to discuss prioritization of subpopulations for the emergency housing vouchers. As directed by the CoC Board, additional CoC Board members were present during the discussion and took part in the following recommendations.

The CEA committee approved the following target population percentages:

- 30% Chronic homeless dedicated
- 30% Permanent Supportive Housing Chronic Homeless Dedicated programs
- 10% Chronic Homeless high use medical care
- 20% families (homeless/housing instability in RRH)
- 5% Transitional age youth
- 5% Survivors of domestic violence/human trafficking

In addition, the CEA Committee approved the following to be paired with referrals from Coordinated Entry for the vouchers:

Referrals for the chronically homeless and TAY will prioritize the ability to demonstrate eligibility for on-going case management services. This will include exploring options such as but not limited to:

- a. Savings in housing expenses which can be applied to case management.
- b. Medical case management.
- c. Criminal justice programs.
- d. Funding from the cities.
- e. The Commons project in Santa Rosa.
- f. ESG-CV funds.
- g. Other development of homeless-targeted housing in Sonoma County.

Staff Recommendation

The CEA Committee and Staff recommend the CoC Board approve the recommendations for the Emergency Housing Vouchers.



FACT SHEET

The California Statewide Survey of Homelessness (CSSH)

The California Statewide Survey of Homelessness (CSSH), conducted by the UCSF Benioff
Homelessness and Housing Initiative (BHHI) with financial support from the BHHI, Blue Shield
Foundation of California and the California Health Care Foundation, aims to inform policies,
programs and perspectives in order to prevent and end adult homelessness in California. The
CSSH will use survey data and in-depth interviews to achieve five aims:

- 1) To understand the characteristics of adults experiencing homelessness in California
- 2) To characterize the immediate precipitants of homelessness
- 3) To characterize people's experiences while homeless
- 4) To understand the barriers to exiting homelessness and obtaining housing and
- 5) To understand the impact of the COVID-19 on homelessness.

Inspired by a request from Health and Human Services Secretary Mark Ghaly, the CSSH will provide data to complement, but not replicate, data from the Point in Time count, Homeless Management Information System and Homeless Data Integration System.

Where Will the Survey Take Place?

We have chosen 8 counties (and expanded one to a two-county cluster) that will allow us to draw state-wide estimates. We chose counties to represent California's diversity: urban and rural, Northern and Southern, Coastal and Inland. We will use venue- and respondent-driven sampling approaches to ensure that we are able to draw a sample that represents all homeless adults in the area.

Who Will Be Surveyed?

We plan to conduct structured interviews with approximately 350 and 500 participants in each county, in order to draw reliable estimates. All adults experiencing homelessness, whether as single adults or in families, will be eligible. We will conduct interviews in English and Spanish and other threshold languages (depending on the County). To further our understanding of the population, we will conduct a series of qualitative interviews. This research involves in-depth, recorded interviews with selected participants.

What Role Will Local Communities Play?

We will convene **three community advisory boards (CABs)** to provide input into all aspects of the study. The CABs will include: 1) people with lived experience of homelessness from throughout the State; 2) local, state, and national representatives of homeless system practitioners and policymakers and 3) a learning community of representatives from the 8 participating counties. They will offer guidance on data collection tools; sampling; data interpretation; and dissemination of the study findings.

To design and conduct each study, UCSF BHHI faculty and staff will work alongside leaders and community members in each county to design data collection efforts to insure we reach even the most hard-to-reach populations. Additionally, in each county, we will hire and train a team of people (those with lived expertise or college students) to administer the 45-minute questionnaire. We will provide financial support for organizations that partner with us and hourly salary for the interviewers. Although we will work closely with our county partners throughout the duration of the study, we plan to minimize work on the part of local leadership.

What Kinds of Questions Will Be Asked?

The questionnaire includes questions about precipitants of homelessness; alcohol, drug, and mental health issues; the personal impact of COVID-19; current income and benefits; current and prior intimate partner violence exposure; housing and health service utilization; and respondents' perceptions of interventions that would help them achieve stable housing. Based on their responses to the questionnaire, we will invite certain participants to complete a qualitative interview to describe their experiences and perspectives in depth.

How will the Data Be Used?

The findings will provide a State-wide picture of homelessness, increase our current knowledge, and fill existing knowledge gaps about unsheltered populations and homelessness, examine the effects of COVID-19 on homelessness, and inform local and State policy decisions. BHHI will disseminate these findings through presentations, reports, editorials, and academic journal articles. While we will not publicly identify county-level data, we will provide each County with data from their own County, to inform internal planning and policies.

When Will the Survey Take Place?

We plan to collect data in each **County for approximately three weeks,** after a planning process. **We plan to initiate data collection in the summer of 2021**; **we anticipate it will take 15 months to complete data collection.** We will issue interim reports throughout the data collection period.
