HOUSING CHOICE VOUCHER (SECTION 8) WAITLIST LOTTERY INFORMATION

The Sonoma County Housing Authority's Housing Choice Voucher (Section 8) Waitlist Lottery will be open from Friday, October 1, 2021 through Monday, November 01, 2021. Mailed applications **MUST** be postmarked by November 01, 2021. **It does not matter when you complete the application during that time period. Each application will be considered in the lottery, regardless of when it is submitted within that time frame.**

This application does not guarantee placement on the waitlist. The final waitlist will be determined using a random lottery. Applicants not selected in this lottery will not move forward in the process and will be notified of their status, along with households that make the list. Waitlist lottery results are final and are not subject to appeal. Households not selected for this waitlist may reapply when the waitlist application period reopens. Information regarding the date, time and place of future waitlist openings will be posted in advance on this website <http://sonomacounty.ca.gov/CDC/Housing-Authority>.

Applications that are selected for the lottery will be ranked by preferences and randomly assigned applicant ID numbers. The Sonoma County Housing Authority has established the following local preferences for applicants with household members in the following groups:

- Persons with disabilities
- Seniors (62+ years of age)
- In-Place Preference
 - This limited preference applies only to those who have been living in a unit in the jurisdiction of the Sonoma County Housing Authority (**WITHIN** the County of Sonoma and **OUTSIDE** the city limits of Santa Rosa) for at least three months and the owner/manager is willing to accept the Housing Choice Voucher Program if the applicant is approved.
 - Documents required at the time your name is reached on waiting list:
 - A letter from the owner/manager certifying that they will accept the voucher.
 - A copy of applicant's lease in an appropriate size dwelling for the family listed in the housing application.
 - Copies of utility bills for a 3 (three) month period verifying residency in the unit.

** Should a voucher be issued using this preference and the voucher is unable to be utilized in the "in place" unit at the time of voucher issuance, the voucher will be rescinded and the applicant returned to the waiting list.**

You will be required to provide documentation for preferences that apply to your household when your name is reached.

If you move after submitting the preliminary application, it is your responsibility to submit a WaitlistUpdate Form, which is available at the Sonoma County Housing Authority office or online at: <http://sonomacounty.ca.gov/CDC/Housing-Authority/Applicants/>

If we are unable to contact you at the address provided, you will be removed from the Waiting List. **Please note: *The post office will not forward mail from our office.***
