Addendum 2, Item 1 - Engineer's Estimate clarification.

The Engineer's estimate for this project is \$1,847,715.

Addendum 2, Item 2 – Response to DBE question.

Submitted question: "Is there a DBE goal and Good Faith Efforts required for this project? The notice to bidders states that there is an overall state goal, but DBE/GFE forms are part of the bidder's book. Please clarify."

Response: There is no contract goal for this project and no good faith efforts are required.

Bidders, however, are required to submit documentation on which DBEs they are using as subcontractors and for which line items the work will occur. Sonoma County Transit is required to monitor DBE activity and report results to the Federal Transit Administration (FTA).

The forms required to be completed and submitted with the bid are the 10-01, 10-2, 12G, and 15G. 15H should not have been included in the bid book. It is not required to be completed because there is not a contract goal and good faith effort is not required.

The following sections were missing in the special provisions and are added per this addendum:

2-1.02B SUBMISSION OF DBE INFORMATION:

There is no good faith effort process with a race neutral program.

The required DBE information shall be submitted on the "LOCAL AGENCY BIDDER – DBE INFORMATION" form included in the proposal. If DBE information is not submitted with the bid, the DBE information shall be removed from the documents prior to submitting the bid.

The Bidder's DBE information shall include the names, addresses and phone numbers of the DBE firms that will participate, with a complete description of work or supplies to be provided by each, the dollar value of each DBE transaction, and a written confirmation from the DBE that is participant in the contract. A copy of the DBE's quote will serve as written

confirmation that the DBE is participating in the contract. When 100 percent of a contract item of work is not to be performed or furnished by that DBE, a description of the exact portion of that work to be performed or furnished by that DBE shall be included in the DBE information, including the planned location of that work. The work that a DBE prime contractor has committed to performing with its own forces as well as the work it has committed to be performed by DBE subcontractors, supplies, and trucking companies will count toward DBE participation.

2-1.10 DBE GOAL FOR THIS PROJECT:

Sonoma County Transit’s current DBE program is Race Neutral and as such does not use contract specific goals. However, any DBE participation on the agreement is calculated towards the Overall 3-year DBE goal.
