North County Presentation -

Kim Bender – HealthCare foundation of Northern Sonoma County executive director – Presentation Improving Mental Health - how do we improve MH before clinical interventions? PP Presentation

- Website <u>www.healthcarefoundation.net/strategic-plan</u>. The strategic plan is the result of the research that was done. They are hoping to expand the project to Healdsburg and Windsor.
- Questions
 - Peter McAweeney How many students are in the mental health pipeline and what is expected
 of the next few years?
 - Answer pilot of the program launched in 2018, at that time students were different points in their educational career. Currently 15 students are in the program, some have complete and some are just beginning. Program started out giving partial scholarships and signing bonus and two-year retention bonus if they worked at a job in Northern Sonoma County. They learned from the pilot is that there were not enough jobs in those areas so they changed ended up giving those bonuses when someone took the job anywhere in Sonoma County. Also worked with donors and listened to the participants after the pilot years and were able to secure full tuition scholarships so that students came out of their education with less debt. Had a massive impact on the interest in the program. Now average about 25 applicants for the 4 spots in the program. Trying to commit to the program for the next 10 years.
 - Michael Reynolds question Is there any intention to include diversity in the hiring of those does the work? To Include local business and minority businesses in projects?
 - Answer-they are looking at using a model to hire from the community so that it gives the community a sense of pride and social capital. Looking at Pogo Park as an example.
 Sonoma Valley project are in the works, hope to hire local and have the local community

take full ownership of the project. There is also funding traineeships one in Cloverdale and one in Healdsburg, going to continue for next year.

- o Bob Cobb question How can we become engaged in MH efforts for north county?
 - Answer if you live in Cloverdale we got funding for a project so there will be more information in July. You Can sign up for the newsletter on the website.

Guadalupe Navarro and Saraisabel Virgen – Latino Service Providers Power Point Presentation about what Latino Service Providers is. Community outreach with Youth Promotores.

- LSP Weekly Newsletter and Monthly Meetings.
- Organizers of Stop the Stigma event.
- Youth Promotores program is designed to engage Latinx youth and improve their overall mental health in well-being.
- Questions
 - o Michael Reynolds what is the secret for the success of the youth Promotores program?
 - Answer—Retention is a challenge especially with students. LSP has built relationships that allow students to feel like they are a part of the program. 90% percent retention rate for the program. Valuing their time and acknowledging their projects with compensation. Also having a team that works directly with the youth, a bilingual bicultural staff that know how to support the youth in the program. LSP is there to support the youth in the program, the youth is considered the leaders of the program.
 - o Kathy Smith Is the Promotores program unique to Sonoma County?
 - Answer- Yes, it is unique to Sonoma County. The program is constantly evolving and more funding is allowing the program to expand. Goal is to continue growing the program. LSP has a 5-year report will be published. LSP will be going to Chicago in a few weeks to present about the youth promotores program.
 - Kathy Smith re Promotores present in North County HS?
 - Answer- Yes, there is a presence. A challenge was building a budget to provide a stipend for transportation so that students are able to attend meetings.
 - o Kathy Smith question, Have COVID and ZOOM helped with transportation issues?
 - Answer-Yes, but there is Zoom fatigue so we had to get creative to have the meetings be exciting and interactive. But it allows for us to branch out and have promotors from Marin and Solano. In the virtual space that works, but we are now implementing a hybrid model in order to create more opportunities to more students from other counties.

Becky Ennis, SOS Community Counseling

- Mental health talent pipeline, students and former students. Some of the work that SOS has been doing in Sonoma County, have programs Cloverdale, Healdsburg and Windsor. Starting to have some in Cotati and Rohnert Park and moving into Petaluma.
- In Cloverdale have opened a clinic at senior center, hoping to support seniors with mental health needs through counseling. Have two counselors, one bilingual in Spanish and one being of the demographic.
- On the middle school and high school campus, SOS has placed clinicians there. To date they have served 86 students in Cloverdale with 1:1 counseling,

- Prior to COVID about 1600 classroom presentations were conducted in North County. The
 presentations are based on MH topics that are important to the students receiving the presentations.
- The third program in Cloverdale has been a Juvenile Diversion Program. They have two police officer hat are also licensed Clinicians that work in Windsor, Healdsburg and Cloverdale. The program pulls kids that are higher risk, those that are dabbling in illegal activities to help to counsel them in order to avoid them becoming part of the Juvenile Justice System. Timeline is 10 to 12 weeks depending on the misdemeanor that is a first-time offence. Also pull student that have issues with truancy, suspension or possible expulsion. In 2021 this program has served 47 youths between the ages of 10-18 in Cloverdale. 99% success rate, only 1% have reoffended. In Healdsburg since 2018 the program has served 171 youth between ages 10-18 with a 97% success rate. In Windsor this program has been operating since 2017, 196 youth have been served, ages 9 to 18 with a 96% success rate.
- Hope to have annual report out by end of summer.
- Questions/ Comments
 - Sherry comment, Thank you for what all the organizations are doing.
 - Lupe Navarros comment, LSP is very appreciative of SOS and the relationship that they have together. Great to have the impact of two agencies working alongside each other for creating spaces and opportunities for group and individualized therapy.
 - Betzy Chavez question, If there is any feedback to those you are providing to those who are working with youth in the Juvenile system? Also, do you have any connection to Hannah Boys Center?
 - Answer No connection with the Hannah Boys Center, but would love to talk about that. They do work with the Hannah Institute. In having conversations with the Police Chiefs that they work with, all are incredibly supportive but sometimes it is tough to see changes after those conversations. Would love to see more trainings with street officers.

Mary- Frances Walsh – Executive Director of National Alliance of Mental Illness (NAMI) Sonoma County affiliate

- What NAMI does in Sonoma County nationwide organization they operate a warm line that gets about 60 new callers a month from family members trying to figure out how to get resources for mental health.
- Services that NAMI offers are education, awareness, support and the warmline. Since March of 2020, everything is virtual. This had expanded the reach to different counties in Northern CA. For the time being the program is open to anyone who needs help.
- For North County there are new programs like the SAFE team and inRespone teams but they can rarely make it up to Cloverdale in a timely manner. These services are geographically limited.
- Most programs in North County are designed to help with people who are experiencing mild to
 moderate. Even though there are needs for the more severe symptoms such as psychotic episodes.
 Pandemic ended visits from a psychiatrist. No staff pediatricians, no in person support at the moment.
 People are not being connect with treatment or cannot/don't want to travel to treatment. Houseless people are no longer coming into the clinics since the pandemic. Lack of supportive housing,
 psychiatrist and difficulty helping patients who need medications.

Wendy Wheelwright - BH Directors Update

- BH director selected and will start in May. This person is bilingual in Spanish and lives in Sonoma County.
- Substance Use Disorder section (SUDS) new program manager has started.
- Sage Commons has opened and it is full, working to build community on site. They have case managers and support on site.
- BOS approve mobile services expansion to North County. There will be a dedicated MST response team, recruitment has started for this. In addition, for the CalAIM updates and screening teams, BH has been meeting with community partners to look at streamlining processes and making successful referrals within the system.
- Whole Person Care team to do in reach services within jails.
- Chris Marlow who is the lead on CalAIM can provide a more in-depth review if needed.
- CalMHSA ia doing a job task analysis survey for Peer Certification, they have a survey up on the website right now in order to inform this process.
