FY 21-22 Year End Expenditure Report Summary was presented. Surplus budget ~\$2.68M combined with higher-than-expected revenue from growth (performance) ~+\$1.7M means we ended this fiscal year with a fund balance of \$12,457,643 or 7.5 months of FY 22-23 budgeted expenses.
