5. FY 23-24 Budget Development—Brad Hecht

FY 22-23

Approved Budget: ~\$17.8M Year-End Estimate: ~\$15.9M Projected Surplus: ~\$1.9M¹

FY 23-24 (all departments requested status quo budgets)

Continuing Programs: ~\$19.9M²

Proposed Changes: 0

Approved Budget: ~\$19.9M

- 1. Health Services and Human Services assumed to fully expend budgets
- 2. Increase due to inflation and programs funded for only part of FY 22-23 but for full year in FY 23-24

CCP Revenue and Expenditure Projection

FY 23-24

MAIN AB 109 GROWTH (after 10% to Local Innovation Subaccount)

Expected before January 10 budget: ~\$825K Expected as of January 10 budget: ~\$122K

FY 23-24 Projected Base + Growth is ~\\$1.7M less than previously expected.

Economic Indicators present a slow rate of fiscal growth.

CCP Funding Summary

Fund Balance:

Projected FY 22-23 yearend fund balance = \$16.6M or 10 months of expenditures

Revenues:

Excluding volatile growth, revenue expected to increase slowly

Expenditure:

Projected structural deficit = 10% per year (projected spend of \$110 for every \$100 received)

Recommendation

Adopt a status quo budget as presented today.

Pending May Revise and salary negotiations, CCP may consider budget options.

A discussion ensued.

Chief Fuchs: Proposed voting on the recommendations, with the caveat that between now and budget submission, this committee will reconvene prior to March 1st for budget adjustments for administrative purposes up to 5% or \$20K (whichever is lower). Alternately, vote on the budget and remove an ISD and a Sheriff's Office line item due to past spending trends, totaling \$125K.

Motion: Brian Morris moves to approve the budget, status quo with the ability to adjust up to 5%

or \$20K.
