4. Discussion: Juvenile Recidivism Analysis – Samantha Feld

- a. Baseline definition: Recidivism is one way to track success of youth who have moved on from probation or were diverted from probation.
- b. Presentation of Juvenile Recidivism Analysis Overview
- c. We will have some preliminary results to share by the next meeting of the JJCC.
 - Q: Chris Castillo: It appears the analysis is based on individuals identifying with one race/ethnicity. Consider capturing bi-racial/bi-cultural youth.
 - Q: Chief Kilgore: Is there a plan to expand beyond binary genders and single racial/cultural tracking?
 - A: Rob: Potential with implementation of a new data management system.
 - Q: Chief Kilgore: Has any data been collected on a potential nexus between a lack of proper ethnicity sensitivity and experience or recidivism?
 - A: Rob: We recognize that we need more data collected from youth. Would be a good way to shape what we want to do. Need representation of people who are in the system and what do we need to do for them to be able to be addressed the way they want to.
 - A: Judge Gnoss: Juvenile Probation has been sensitive to these issues and good about providing that information to the court.

- 5. Discussion: Comprehensive Multi-agency Juvenile Justice Plan prioritization Haunani Pakaki
 - a. Plans are typically completed in two-year cycles. A Subcommittee will be formed to work on specific goals, using voting and non-voting members of this Council.
