- 1. There are just over 250 youth on supervision, today. The count is trending upward and has nearly reached 2019 levels. It is unknown if it will continue trending upward.
- Juvenile Hall population is now over 60, which is higher than 2019 levels, though this includes 16 SYTF youth (12 from Sonoma and 4 from other Counties), and some youth who might have been in Probation camp in prior years are likely now in Juvenile Hall.
- 3. In 2023 and 2024 (estimated based on nine months of data) Probation received about 250 felony referrals and 150 misdemeanor referrals per year. Felony referrals are currently 25% above pre-pandemic levels, and Misdemeanor referrals are 50% lower.
