**Project Description:** The project involves approval and implementation of the *Hood Mountain Regional Park and Open Space Preserve - Lawson Expansion Master Plan (Lawson Expansion Master Plan)*, which was developed to address public access improvements, natural resource management activities, ongoing operations and maintenance, and community engagement for two new parcels that have been added to the existing Hood Mountain Regional Park and Open Space Preserve that will add a total of 247.26 acres to expand the Park from 2,195.41 to 2,442.67 acres. The Hood Mountain Park & Preserve – Lawson Expansion Master Plan describes the expansion properties and identifies objectives and actions that will help meet Regional Parks' goals for the two parcels.
